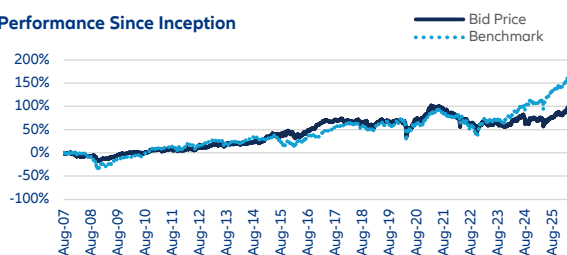

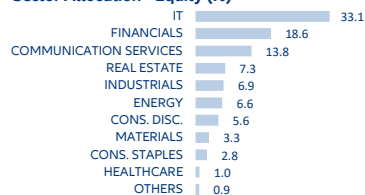

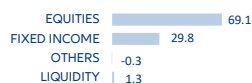

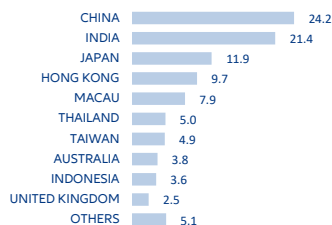
Sector Allocation - Equity (%)



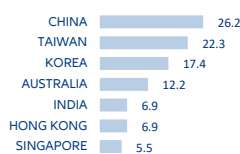
Asset Allocation (%)
