The Allianz Life Global Unconstrained Equity Fund (the "Fund") seeks to achieve long term capital growth.

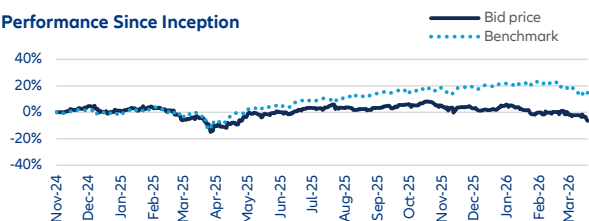

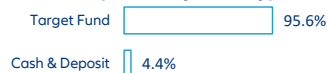

## Portfolio Composition by Asset Type

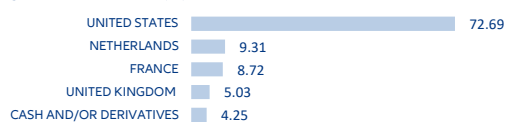

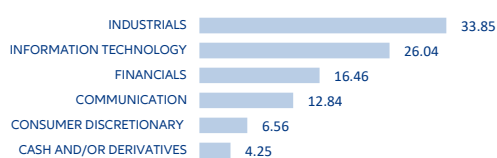
